1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. CONGRESSIONAL APPOINTMENT OF MEMBERS
4	OF MACPAC.
5	(a) In General.—Section 1900(c) of the Social Se-

6 curity Act (42 U.S.C. 1396(c)) is amended—

1	(1) in paragraph (1), by striking the period at
2	the end and inserting the following: ", except that
3	for terms beginning on or after January 1, 2017,
4	such members shall be appointed as follows:
5	"(A) Six by the Speaker of the House of
6	Representatives, in consultation with the chair-
7	man of the Committee on Energy and Com-
8	merce of the House of Representatives.
9	"(B) Three by the minority leader of the
10	House of Representatives, in consultation with
11	the ranking member of such Committee.
12	"(C) Five by the majority leader of the
13	Senate, in consultation with the chairman of
14	the Committee on Finance of the Senate.
15	"(D) Three by the minority leader of the
16	Senate, in consultation with the ranking mem-
17	ber of such Committee.";
18	(2) by amending paragraph (2) to read as fol-
19	lows:
20	"(2) Application of ethics rules.—Mem-
21	bers of MACPAC shall be treated as employees of
22	Congress for purposes of applying title I of the Eth-
23	ics in Government Act of 1978 (Public Law 95–

1	(3) in paragraph (3)(A), by inserting "or Con-

9	(1) Initial appointment.—The terms of
10	members of the Medicaid and CHIP Payment and
11	Access Commission, as in effect as of the date of the
12	enactment of this Act, shall all expire on December
13	31, 2016. Congressional officials shall appoint new
14	members to the Commission pursuant to the amend-
15	ment made by subsection (a)(1) and the terms of

18	(2). Nothing in this section shall be construed as

7	Representatives, two for a term of 3 years, two
8	for a term of 2 years, and two for a term of
9	1 year.
10	(B) House minority leader's appoint-
11	MENTS.—For members appointed by the minor-
12	ity leader of the House of Representatives, one
13	for a term of 3 years, one for a term of 2 years,
14	and one for a term of 1 year.
15	(C) Senate majority leader's ap-
16	POINTMENTS.—For members appointed by the
17	majority leader of the Senate, one for a term of
18	3 years, two for a term of 2 years, and two for
19	a term of 1 year.
20	(D) SENATE MINORITY LEADER'S AP-
21	POINTMENTS.—For members appointed by the
22	minority leader of the Senate, one for a term of
23	3 years, one for a term of 2 years, and one for
24	a term of 1 year.
